All information collected/processed will be kept in a secure manner, where applicable, it will be kept in accordance with the applicable laws and regulations to prevent the unauthorized or unlawful processing of your personal data / personal information and the accidental loss or destruction of, or damage to, your personal data / personal information.
- 4. The personal data / personal information you provided will be collected, used and processed by us for the following purposes:
 - a. to deliver notices, newsletter, promotions, services or products and the marketing materials of such services or products whether present or future to you;
 - b. for FC's customer relationship management;
 - c. to conduct marketing, survey, questionnaires, legitimate business activities and client profiling activities in connection with our services and related products:
 - d. internal record keeping and maintenance of customer database.
 - e. to facilitate the provisioning of services or products in accordance to customers specifications;
